##### 1. 55/45 Class A Blouse Coat

- a. Available options – Blauer 8590, Flying Cross 34891, Anchor 210BLC
- b. Question #1 – Are the badge eyelets directly added to the jacket required (as seen in the picture), or can the eyelets be on a badge tab sewn on the jacket with metal eyelets spaced 1 5/8" apart?

#### Answer # 1 - b:

Yes, the shield eyelets are directly added to the jacket. The opening is large enough for the shield lugs to fit through without having to force it. A tab sewn on after the fact does not properly support the weight of the official shield without it moving around

- c. Question #2 – Are there two small Gold NYS on each sleeve cuff? Hard to tell in the picture

#### Answer # 1 – c:

Yes, there are two small gold NYS buttons on each sleeve cuff.

##### 2. "55/45" Class A Trouser

- a. Available options in 55/45 fabric blend – Anchor 230BLC, Flying Cross 37291, Blauer 8585 – These 3 options all require the addition of two back hip club pockets and ½" black ribbon braid as after-market alterations
- b. Available "Stock" versions of this NYPD Admin pant – NYPD Admin pant comes automatically with the two rear club pockets and ½" as part of the style number and are significantly less expensive as a result
  - i. Liberty Uniform 662 – 100% Polyester serge
  - ii. TAC SQUAD F703– 72/25 Poly Wool serge
  - iii. Blauer 8656P7 – 100% Polyester gaberdine


