They serve in a confidential capacity and work with substantial independence from supervision in units located in the Court of Claims or special parts in the Supreme Court or in County, District, Family, and Surrogate's Courts in counties entirely within cities or in counties that have populations exceeding 400,000.

**ASSIGNMENT:** These positions will be assigned to the New York City Family Court. Duties and responsibilities include but are not limited to: conducting hearings to either hear and report or hear and make determinations in Custody, Visitation, and Family Offense matters; taking testimony and reporting findings of facts to judge; researching and analyzing complex legal questions and issues; and writing confidential memoranda and drafting opinions.
