DISTINGUISHING FEATURES OF WORK: Under the supervision of the Chief Security Attendant, Court Of Appeals, Security Attendants, Court of Appeals are responsible for maintaining order and decorum and providing security in the Court of Appeals. They also perform various clerical and messenger duties, may be assigned to ensure the personal security of judges, and perform other related duties.

ASSIGNMENT: Duties include but are not limited to: maintaining order and decorum in court rooms, waiting rooms and other court premises; escorting and providing security to judges within and outside of court premises; ensuring that courtroom is prepared for court proceedings and other administrative tasks. Security Attendants are required to work varying shifts on a rotational basis.

GENERAL INFORMATION: The above statements are intended to describe the general nature and level of work being performed by persons assigned to this title. They do not include all job duties performed by employees in the title, and every position does not necessarily require these duties.
