

Q&A

The New York State Unified Court System (“UCS”), Office of Court Administration (“OCA”) is soliciting sealed bids (the “RFB”) to provide a Class A dress uniform package for Court Officer Trainees (“Uniform Package”), including measurement, fitting and delivery of Uniform Packages to the NYS Court Officer Academy facility, currently located in Brooklyn, New York (hereafter, the “COA”), as well as alteration, refitting, and redelivery as needed. The Uniform Package shall consist of a cap, tie, dress gloves, shoes and tailored-to-fit “Class A” quality blouse and trousers. The deadline for bidders to submit questions in connection with the RFB concluded at 3:00 PM on Thursday, April 16, 2026. The following is a list of questions that bidders submitted by the deadline, with UCS’s responses:
